13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. We plan on plugging this well by placing cement from the top of the perfs to 100' above the top of the Gallup with some extra cement for shrinkage. We will come back and tag to make sure cement is at least 100' above top of the Gallup. We will then perforate at 81 feet which is 50' below the surface casing and circulate cement and fill the production casing and annulus to 50' below the bottom of the surface casing. We will let the cement dry and if necessary, add to top off at surface and will then install a dry hole marker.

surface casing: 7", 28# @ 31'
production casing: 4.5", 9.5# @ 906'
perforations: 851' - 856'

We will plug this well as soon as equipment and manpower are available.
