10/17/07 Frac w/ 794 bbls of borate crosslinked gel with 5,000# of 40/70 & 60,000# of 20/40 BASF sand.

10/31/07 RU Hurricane Well Service. Clean out to PBTD. Ran 56 jts of 2-3/8", 4.7#, J-55, EUE8rd tubing and set @ 1847' KB. Run pump and rods. Turned well over to Production Dept.
