Circ 36 bbls cement to surf. Cemented 2nd stage w/475 sx Prem Lite cement (12.4 ppg & 1.87 cuft/sx) f/b 100 sx Type III cement (14.5 ppg & 1.39 cuft/sx). Circ 39 bbls cement to surf. Finished cement job on 10/5/07.
