Milled window in 7" csg @ MD4123'-28' & drilled 6-1/8" upper PC lateral to MD5867'. Set 4-1/2" 11.6# J-55 liner in upper PC lateral @ 5752' w/top @ 4132'. Liner has 4-1/2" guide shoe on bottom & 5 preperfed & plugged joints w/tops @ 5711', 5308', 4905', 4501', & 4178'. Each preperfed liner joint has 28-0.75" holes. Liner still connected to 114 jts 2-7/8" tbg, 15--4-3/4" drill collars & 1--3-1/2" drill pipe. Released rig on 10/17/07. Waiting on completion rig. ✓
