Upon completion of the planned lateral drill design along with the additional side lateral, it was determined that the portion of lateral lined includes the main lateral up to the junction of the main lateral and side lateral and the portion of the side lateral as indicated on the final directional drilling survey. This lateral showed to be unproductive due to wellbore construction problems.

A third lateral was drilled by setting a whipstock and milling a window as indicated on a subsequent sundry. This lateral was drilled according to the directional wellplan submitted with the afore mentioned sundry. This lateral was drilled to 5915' MD with a BHL of 1553 fnl, 1924 fwl of Section 29, T32N, R4W.

09/27/07 TD:5915' PBTD:5915' Drill 6.25" hole to 5915'. Run 34 jts. 4.50" 11.6# j-55 LT&C casing, set @ 5885'. TOL:4481' (3' outside window). No cement.

09/28/07 Re-run 138 jts. 2.375" 4.7# J-55 killstring tubing, set @ 4464'. Top of window @ 4469'. ND BOP. RDMO.
