Cemented lead w/625 sx (161 bbls) 50/50 POZ foamed cement w/2% Gel, .2% Versaset, .1% Halad-766 and tail w/75 sx (19 bbls) same slurry non-foamed. Did not circulate cement to surface, top of cement determined by Temp survey and CBL which shows to be at 400'. Tested casing to 1,500 psi. No remedial work required
