Landed 2-3/8" 4.7# J-55 tbg in 4-1/2" liner on/off tool @ 4080'. Pumped 1500 gal 20% HCL w/70Q N2 into 4-1/2" liner to dissolve Al plugs. Flowed back & swab tested PC lateral on 11/26/07 for 0 MCF/D. Completed as a single PC horizontal gas well.
