Tailed w/350 sx (455 cf) 50/50 POZ cmt w/5# gilsonite, 1/4# polyflake & 2% Halad 9. Circ. 25 bbls cmt to surface. Plan to pressure test during completion operations. ✓

On 10/27/07, drilled through 7" csg shoe @ MD4131' & drilled 6-1/8" PC lateral hole to MD7145'. Set 4-1/2" 11.6# J-55 liner @ 7145' w/top @ 4080'. Liner has 4-1/2" guide shoe on bottom & 7 preperfed & plugged joints w/tops @ 7103', 6651', 6188', 5690', 5204', 4752', & 4293'. Each preperfed liner joint has 38-0.75" holes. Released rig on 11/1/07. Waiting on completion rig. ✓
