On 11/27/07 the above well was perforated in the Dakota zone from 8,033' to 8,211' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 22 holes. On the same date the well was fracture treated with 55,915 gal Delta 200 with 52,752# 20/40 Ottawa sand. The average rate was 27 bpm, average pressure 2659 psi, and the final frac gradient was 0.71 psi/ft. ✓
