Drilled 6 1/4" hole to 8,247' on 11/9/07, set 199 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,246', with ACP @ 5,346' & Hydraulic DV Tool @ 5,343'. Cemented 1st stage w/260 sx (68 bbls) 50/50 POZ "G", w/3% Gel, .9% Halad 9, .1% HR-5, 2% CFR3, 5#/sx Gilsonite, .125#/sx Poleflake, full circulation throughout job, cement top on 1st stage is to DV Tool @ 5,343'. Cement 2nd stage w/225 sx (56 bbls) 50/50 POZ "B", 3% Gel, .9% Halad 9, 2% CFR3, 5#/sx Gilsonite & .125#/sx Poleflake. No cement to surface, top of cement is at 4,050' determined using CBL. Tested casing to 1500 psi. Drilled out below the 4 1/2" shoe to a new TD of 8,309', with an open hole from 8,246' to 8,309'. Will go back into hole after completion for remedial work to circulate cement to surface.
