11/18/2007 - Ran 9 5/8" 36# J55 LTC casing (8 JTS) to 340' landing casing at 365'. Pumped 50 bbls (245 sxs) of premium class G cement at 15.6 PPG with 1.20 yeild. Full returns during job with 29 bbls clean cement to surface. Tested surface casing to 1000 psi for 30 minutes. All tests good.

11/19/2007 - Notified Steve Haydon of upcoming 7" casing & cement job at 7:00 HRS. **8.75" hole to 2890'**

11/21/2007 - Ran a total of 67 JTS of 7" 23# N80 LTC casing at 2881'.

11/22/2007 - Pumped 290 sxs (97 bbls) lead cement - light premium at 12.4 ppg with 1.87 yield. Pumped 160 sxs (36 bbls) - tail cement - 50/50 POZ at 13.5 ppg with 1.3 yield. **TOC @ surface**
