Elm Ridge Exploration CO LLC, reached a TD of 5926' on the above well as of 11-19-07. On 11-21-07 we drilled a 7 7/8" hole and ran 150 joints of 5 1/2" J-55 15.5# casing to 5907.83'. Pumped 510 sks of 65/35/G/POZ cement, 6% gel, 5# Gilsonite and 1/8# of Pol-E-Flake Circulated 14 BBLS of good cement to surface. Pressure tested well to 2500 PSI for 30 minutes on 11-21-07, tested good. Larry Pixley and Marko Kecman with the BLM were both notified of casing and cement operations, but neither were present.
