XTO Energy Inc. has set two cement sidetrack plugs that were necessary due to the inability to land the wellbore in the Basin Fruitland Coal at an angle sufficient to drill horizontally through the coal. The first plug was 150 sx of Class G neat mixed at 17.0 ppg & set from 1518' - 1868' MD. Following this, the second plug was set from 1197' to 1525' MD using 140 sx of the same slurry. Verbal approval of this operation was given by Wayne Townsend on 11/2/07. ✓
