Cemented 2nd stage w/446 sx HLC cement (12.4 ppg & 1.87 cuft/sx) f/b 100 sx 50/50 Poz (14.5 ppg & 1.39 cuft/sx). Circ 50 bbls cement to surface. Finished cement job on 11/9/07.
