Test blind rams, all flanges and all valves to 250#/5 min, 3000#/10 min. OK. Test pipe rams to 250#/5 min & 3000#/10 min. Tested csg to 1500#/30 min. Slow leak. BLM was present & requested cmt to surface & bond log on 4 1/2" Production Casing. Drill ahead was approved by BLM.
