Maralex Resources, Inc. plugged and abandoned the above-captioned well on 12/6/07 as follows:

12/03/07 MOL and RU. Check pressures: 110 PSI tubing and casing; blow down. Well flowing water out tubing. Pump 10 bbls of water down tubing to kill well. ND wellhead. Pull slips. Threads on wellhead for 5.5" wellhead. Remove wellhead. Install A-Plus 2875" wellhead. NU BOP and test. Fill the bradenhead annulus with 0.25 bbl water. Pressure test bradenhead to 300 PSI for 10 minutes. TOH and LD 42 joints 1" tubing. Note: tubing had scale. Pump 20 bbls water 2 bpm at 250 PSI down casing. Plug #1 mix 60 sxs Type III cement (80 cf) and pump down the 2.875" casing filling from PBTD to surface. Casing pressure increased up to 1500 PSI. SI well for 30 minutes. Open up well; no flow ND BOP. Found cement at surface. RD unit. 12/06/07 Issue Hot Work Permit. Monitor for gas around wellhead. Cut off wellhead. Found cement at surface in both the casing and 7" casing annulus. Mix 10 sxs Type III cement and install P&A marker. RD. MOL.
