Elm Ridge Exploration Co, LLC reached a TD of 5170' on 12-6-07. We drilled a 7 7/8" hole on 12-6-07, we then ran 5 1/2" 15.5# J-55 casing to 5162'. On 12-7-07, we pumped 290 sks 50/50/G/POZ. On 12-7-07 we tailed in w/ 632 sks of 65/35/G/POZ cement. We pumped 83 bbls of displacement w/ no returns. Terry Lindeman called Chralie Perrin at the OCD and got a verbal ok. We ran a CBL on 12-21-07. The Log showed we had cement at surface. This well was pressure tested to 3000 PSI on 12-7-07 for 30plus minutes.
