XTO Energy Inc. spudded 13-1/2" surf hole on 12/16/07 & drilled to 330' (surf TD). Set 9-5/8", 36#, J-55 casing @ 316' on 12/17/07 & cemented w/290 sx Type V cement (15.6 ppg & 1.18 cuft/sx). Circ 12 bbls cement to surf. Finished cement job on 12/17/07. Pressure tested casing to 1000 psig f/30 min. Tested OK.

Drilled 8-3/4" hole to 2090' (int TD) on 12/25/07. Set 7", 23#, K-55 casing @ 2090' on 12/27/07 & cemented w/185 sx Class A cement (12.4 ppg & 1.99 cuft/sx) f/b 85 sx Type A cement (13 ppg & 1.58 cuft/sx). Circ 30 bbls cement to surf. Finished int cement job on 12/27/07. Pressure tested casing to 1000 psig f/15 min. Held OK.
