Cemented 2nd stage w/480 sx Prem Lite cement (12.1 ppg & 2.08 cuft/sx) f/b 100 sx Prem Lite cement (12.5 ppg & 1.97 cuft/sx). Circ 43 bbls cement to surf. Finished cement job on 1/13/08.
