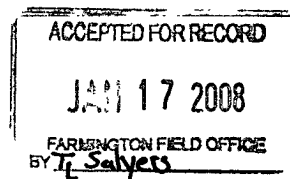

Circ 30 bbls cement to surf. Finished cement job on 12/30/07. Pressure tested casing to 2100 psig f/30 min. Tested OK. ✓
