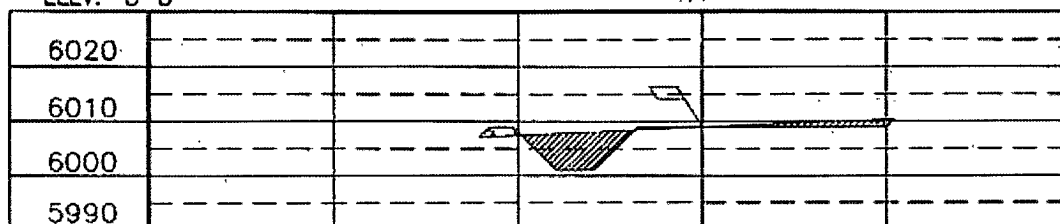
ELEV. A-A'

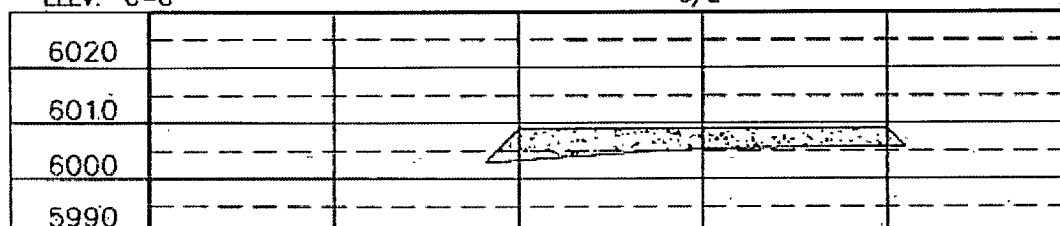
ELEV. B-B'
