BP America Production Company respectfully request authorization to surface commingle gas production from the N Pinon Fruitland Sand & W. Kutz Pictured Cliffs coming from our GCU 517 API 30-045-28156, and Basin Dakota production coming from the GCU 167E API 30-045-24862. The production from each well will be separated prior to the allocation meter. Production from each well will be metered prior to being commingled. The commingled production will then be sent through compression prior to entering the sales meter.

The difference between what is measured prior to commingling and what is sold through the sales meter is the fuel usage. This fuel usage is allocated back to each well based on the well production.

The working interest, royalty and overriding royalty interest owners in the subject wells are different however approval of Order R-12724 allows surface commingling in the GCU without notification. The proposed commingling of production is to reduce operating expenses between the wells and will result in increased economic life of the wells. Surface commingling will not reduce the life of the wells.

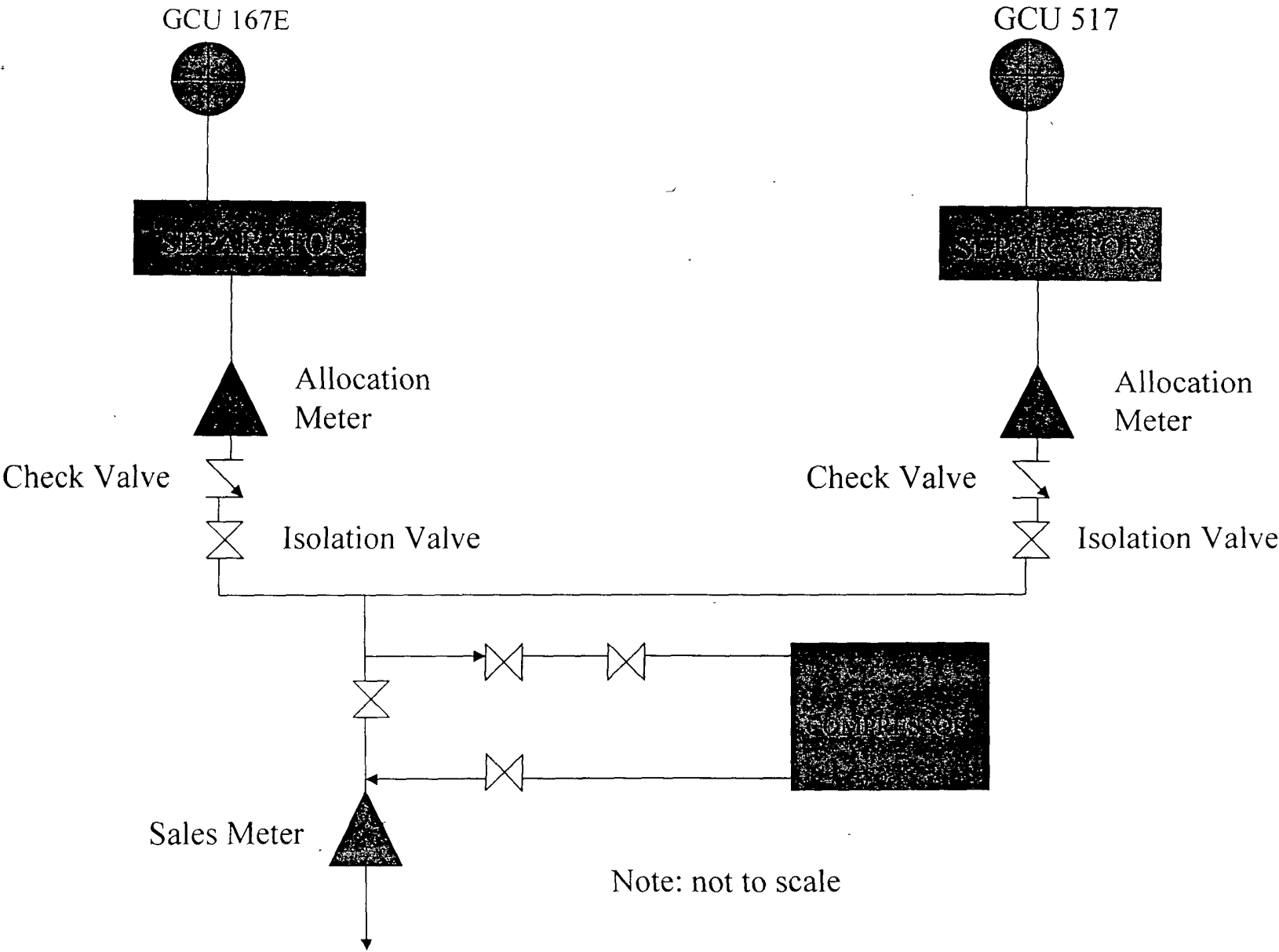

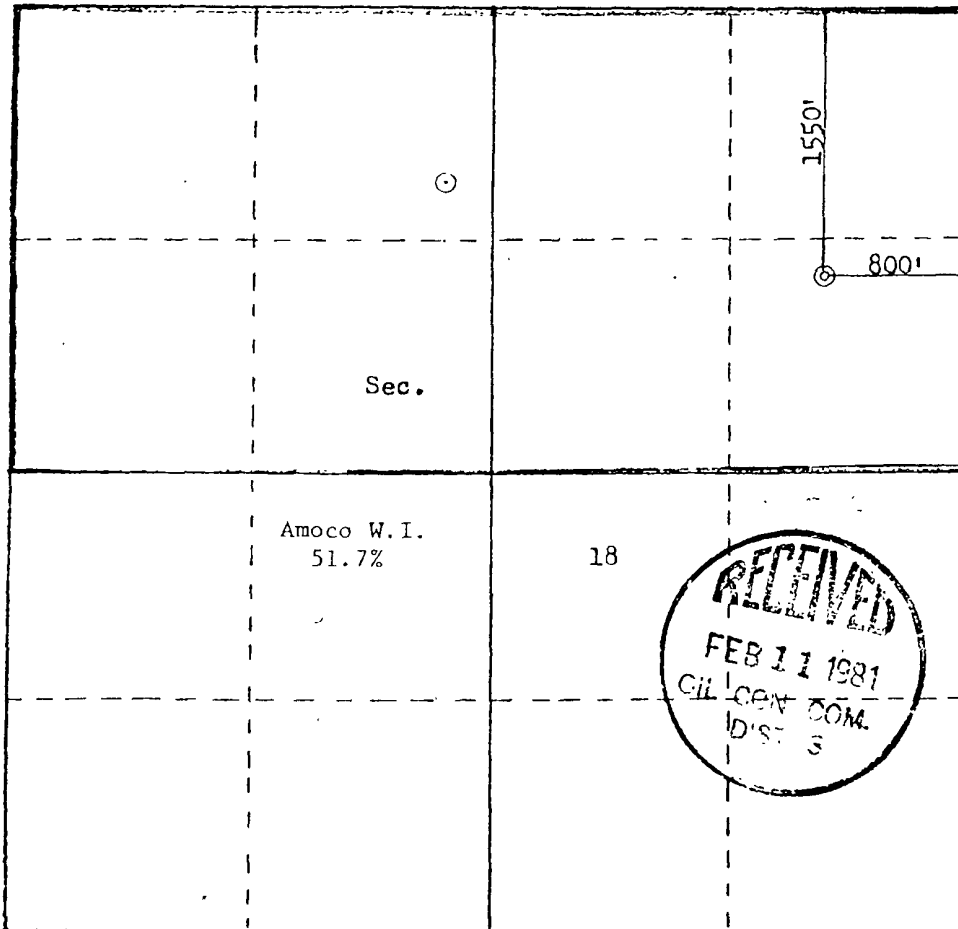
