Production Casing: Drill 8-3/4" hole to 2416' (TD), Ran 62 jts 7", 20#, J-55 csg, landed @ 2403'. Cement w/ 135 sx 35/65 LTPO, 11.5 ppg, 2.99 yield. Tail w/ 115 sx 50/50 POZP, 13.5 ppg, 1.84 yield. TOC for Production Casing is estimated @ 100' as they got "all" of their preflushes back to surface.
