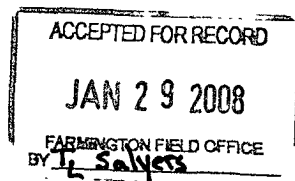
11/1/2007 - Ran 9 JTS of 9 5/8" 36# J55 LTC casing to 384' in a 12 1/4" hole. Tested lines to 3000 psi. Pumped 52 bbls (245 sxs) of Class G at 15.6 ppg with 1.20 yeild cement. Full returns during job with 2 bbs (10 sxs) cement to surface.

11/9/2007 - Ran 67 JTS of 7" 23# N80 LTC casing to 2870' in a 8.75 hole. Tested lines to 3000 psi. Pumped 100 bbls (300 sxs) of 12.4 PPG at 1.87 yeild lead cement and 46 bbls (202 sxs) 13.5 PPG with 1.28 yeild tail cement. Full returns during job with 30 bbls (90 sxs) clean cement to surface.

11/14/2007 - Ran 4 1/2" 11.6# N80 LTC casing to 7665' in a 6.25" hole. Tested lines to 3000 psi. Pumped 148 bbls (590 sxs) of 13.1 PPG with 1.41 yeild cement. Estimated TOC at 1270'.
