Set 8-5/8", 24#, J-55, ST&C casing @ 230' on 01/27/2008 & cemented w/165 sx Type A cement (15.6 ppg & 1.18 cuft/sx). Circ 12 bbls cement to surf. Finished cement job on 01/27/2008. Pressure tested casing to 750 psig f/30 min. Tested OK.
