Elm Ridge Exploration Co, LLC spud this well on 1-12-08. On 1-13-08, we drilled a 12-1/4" hole to 385'. We ran 9 joints of 8-5/8" 24# J-55 casing to 380'. Pumped 320 sks of Type G cement w/ 2% Calcium Chloride and 1/8# polyflake. Circulated cement to surface w/ 18 bbls of good cement to surface. Pressure tested well to 1500 PSI on 1-13-08 for 30 minutes plus. The BLM was notified but not present for cement job on 1-13-08.
