- 1) Set CIBP @ 3,500'
- 2) Set CR @ 3050'
- 3) Squeeze leak with 75 sx cement w/2% CaCl2
- 4) Drill out cement retainer & cement. Pressure test casing to 500 psig. If required re-squeeze. If casing passes pressure test; drill out CIBP & return well to production.
