Elm Ridge Exploration Co, LLC reached a TD of 5128' on 2-5-08. On 2-6-08 we ran 5 1/2" 15.5# J-55 casing to 5114'. With a 7 7/8" hole. 2-6-08; Pumped 368 sks of 50/50G/POZ cement Circulated 25 bbls of good cement to the surface on 2-7-08; Pumped 140 sks of 65/35/G/POS cement. Tailed in w/ 411 sks of 65/35/G/POS cement. Lost returns 13 bbls into displacement, while well would "Belch" periodically, full returns were never established. Marko Kecman was notified but not present, test well to 1500 PSI for 30 minutes plus.
