Circ 5 bbls cement to surf. Cemented 2nd stage w/341 sx (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Neat cement (14.5 ppg & 1.39 cuft/sx). Circ 53 bbls cement to surf. Finished cement job on 1/31/08.
