Elm Ridge Exploration Co, LLC reached a TD of 5123' on 1-23-08. On 1-24-08 we ran 127 Joints of 5 1/2" 15.5# J-55 casing down a 7 7/8" hole to 5118'. Pumped 346 sks of 50/50/G/poz cement in stage one with 25 bbls of good cement to surface. Second stage we pumped 560 sks of 65/35/G/POZ Circulated 22 bbls of to good cement to surface, then lost circulation. Pressure tested well to 1500 PSI for 30 plus minutes.
