Elm Ridge Exploration Co, LLC reached a TD of 5139' on 2-20-08. On 2-21-08 we ran 124 joints of 5 1/2" 15.5# J-55 casing down a 7 7/8" hole to 5124'. Stage one 2-21-08 we pumped 368 sks of 50/50/G/POZ cement, circulated to surface with 32 bbls of good cement. Stage two 2-22-08 we pumped 547 sks of 65/35/G/POZ cement, circulated to surface w/ 19 bbls of good cement. Pressure tested well to 1500 PSI for 30 plus minutes. Marko Kecman was notified but not present for job.
