A 12-1/4" hole was spudded 2-14-75 and drilled to 124'. The hole was ressed to 17-1/4" to 124' where the 13-3/8" ourface casing was set with 140 eachs Class "D" cement with 2% CaCl2 2-15-75. Tested BOP & manifold with 700 pai for 1/4 hour OH. Reduced the hole to 12-1/4" at 124' and continued drilling.
