XTO Energy Inc. received verbal approval on 3/27/08 from Jim Lovato/BLM & Henry Villanueva/OCD to sidetrack this well a second time. The work was estimated to begin @ 4 p.m. on 3/27/08 & will be as follows:

Set plug on fish @ 1857' MD in 6-1/8" hole. Pump +/- 75 sx to bring cement 200' inside 7" casing. Tag cement to verify top. Set & orient whipstock in 7", 26# casing @ +/- 1128' MD (+/-1115' TVD) on azimuth of 90 degrees. Re-drill curve & land on same azimuth. Drill +/- 1000' of horizontal & bring back to original azimuth of 103 degrees to TD. Tagged cement @ 1550' on 3/27/08. Ready to drill.
