Top Dakota is at 8705' and the top perf is at 8708'. Top of the Graneros is at 8640', Green Horn @ 8582'. There is a short maker joint located @ 8658'. Requesting to set a CIBP @ 8650' and place 100 To 150' of cement on top.
