In our initial NOI (approved on 05/24/2007), Chevron Midcontinent, L.P. received permission to install and modify its existing surface production facilities to include installing dual flow lines, a 95 Bbl below-grade Pit Tank and a Dynapump Pumping Unit. To complete this installation and upgrade work, we now respectfully submit this request to change our original plans of installing a Dynapump Pumping Unit to that of installing a conventional gas operated Pumping Unit. This will allow us to finally complete this installation and upgrade work in a more efficient, effective manner.
