DIST. 3

This well was permitted as a Fruitland Coal /Pictured Cliffs commingle well. The well was drilled in 2006 and only had the Pictured Cliffs interval completed in 2006. Plans are now to perforate and stimulate the Fruitland Coal interval and commingle the well. Work will be started in approx. three weeks (around May 20th). COPC will follow the original conditions of approval granted with the original APD and the any area disturbed during this process will be reclaimed once the rig moves off. All disturbance will remain within the initial construction zone as outlined in the APD approved 2/15/06.

A steel tank will be utilized instead of a lined earthen pit on this well.
