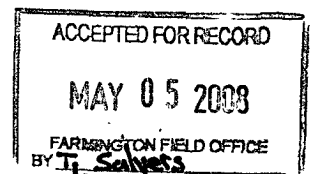

Drilled 6-1/8" hole to 5000' (TD) on 4/16/08. Set 4-1/2", 10.5#, J-55, ST&C casing from 1561' - 4991' on 4/16/08. ✓
