3. Set a balanced cement plug across the Dakota top f/ 5800'-5900' w/ 12 sks of neat cement (50% excess).

4. Set a balanced cement plug across the Gallup top f/ 4965'-5065' w/ 12 sks of neat cement (50% excess).

5. Set a balanced cement plug across the Mesaverde top f/ 2143'-2243' w/ 12 sks of neat cement (50% excess).

6. Set CIBP @ 1500'. Pressure test casing to 2500 psi.

7. Perforate Fruitland Coal according to Geologic Prog.

8. Frac the Fruitland Coal w/ a 70Q foam.
