Drilled 12 1/4" hole to 317' on 5/17/08, set 8 jts of 9 5/8", H-40, ST&C, 32.3# casing at 309'. Cemented w/200 sx (42 bbls) "B" cement w/1% CaCl and 1/4# PSX Floseal. Cement top is at 40', dig out 15' of cellar area with backhoe & dump 100 yards of Type 5 cement to surface, woc, dump dirt and gravel on top of cellar. Method approved by Jim Lovato of BLM. Test casing to 750 psi.
