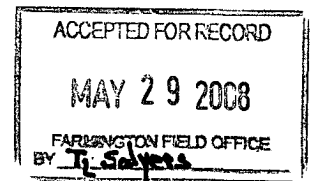

Cement 2nd stage with 445 sks Halliburton Light, 10#/sk gilsonite, 1/8#/sk flocele, 2% CaCl2 tailed by 50 sks Class G, 1/8#/sk flocele (639 cu.ft.). Plug down @ 4:00 am on 05/17/08. Circulate 25 bbls cement to surface. WOC. RD Halliburton. NU BOP.. Test casing & BOP to 1200 psi - ok.✓
