An MIT was conducted pressuring up from 560-575 psi and has successfully completed this test. A pressure bomb was attempted but unsuccessful due to an obstruction in the tubing. We would like to request an extension to change out tubing and run the pressure bomb.

The testing of the well was delayed by the Operations and Reservoir departments for research to ensure the most accurate data possible was obtained for these tests.
