13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. On 5/19/08, the Brookhaven A # 2 was re-perforated over the existing Fruitland Coal interval from 1588'-1598' with 4 spf, 90 degree phasing, 0.43" holes. The perforations were then broken down with 12 bbls of 15% HCL and 12 bbls of 12/3 mud acid. The well was returned to production on Monday, June 2, 2008 at 10:00 AM. The well is producing approximately 60 BWPD and has built enough casing pressure to sell gas.

The gas sales line is in place, however, multiple requests have been made of the gas gatherer for the past 60 days to prepare the meter to measure and sell gas. This work has not been completed. The gas gatherer has indicated they will have the meter ready by 6/13/08. Maralex will continue to produce water off the well and will sell gas as soon as the gathering company has the meter ready.
