The well has not produced since January 2007 because Enterprise gathering company has mandated shut-in of the well due to oxygen in the pipeline. Robert L. Bayless, Producer LLC is currently in negotiations with Enterprise to resolve this issue and, therefore, requests an allowance for continuation of the shut-in status for a period of 180 days. Robert L. Bayless, Producer LLC anticipates that this issue will be resolved within 180 days and the well will be returned to production within the requested time frame.
