On 6/13/08 the above well was perforated in the Pictured Cliffs zone from 3,896' to 3,982' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 24 holes. On the same date 1,000 gal 15% HCL was pumped then the well was fracture treated with 99,440 gal Delta 140 with 186,101# 20/40 BASF coated with sand wedge NT. The average rate was 29.7 bpm, average pressure 1911 psi, and the final frac gradient was 0.61 psi/ft.
