3-7-08: MIRU Basic # 1229. 3-11-08: RU Wire line truck and run logs, found top at 900' TIH with RBP and set at 1100' dumped sand on top while waiting for the BLM to give ok, BLM did not want to shoot squeeze holes, aproved the cement job. 3-12-08: Checked braiden head for pressure and gas flow, checked out negative. Pressure tested well to 3850 PSI. 3-13-08: RU Wire line truck and perforate 4 SPF, 4881' to 4945'. 3-14-08: RU Halliburton, start acid job, pumped 3,440 gallons of 7 1/2% mca w/ hai - 404 fe-la/cia-sta/muscl/losurf, opened well to pit and flowed back 40 bbls then RD Halliburton 3-20-08: Hold safety meeting and start frac job, pumped 1476 mscf of n2, pumped 34,473 gallons of cp delta 140 w/ ssw frac fluid, pumped 1201 sks of 20/40 crc sand. 3-27-08: Bottom of TBG landed at 5008' with 140 joints of 2 3/8" J-55 4.7# TBG, RD and released to production.
