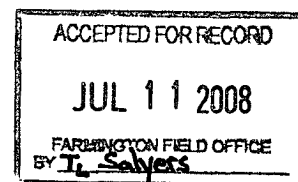

Elm Ridge Exploration LLC has Spud the above well as of June 27, 2008 we Drilled a 12 1/4" hole to 393'. On June 28, 2008 we ran 9 joints of 8 5/8" 24# J-55 casing to 386' we then mixed and pumped 300 sks of STD cement with 2% calc. 1/4# superflake. Circulated 25 bbls of good cement to pit. Pressure tested well to 1500 PSI for 30 plus minutes. Test was good. BLM was notified of operations but was not present to witness job. ✓
