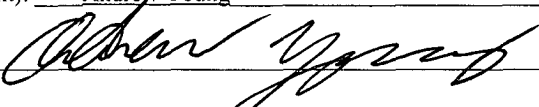

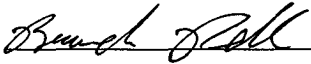

Dear Mr. Powell

Running Horse Production Co. is requesting approval for of a closed loop application. A closed loop system is necessary to provide water and cement recirculation during plugging and abandonment of the Chaco Plant #12 gas well. Running Horse does not plane to use any temporary pits. All waste (which will consist of cement wash-up liquids) will be hauled off location to Envirotech for disposal.

Running Horse Production Co. will construct the closed-loop system to ensure the confinement of water to prevent uncontrolled releases.

No surface disturbance is planned and therefore a reclamation plan is not included. Following P&A, the location will be reclaimed according to BLM Gold Book standards.
