**13. Describe Proposed or Completed Operations**

Burlington Resources ran cement for the 7" Intermediate Casing that is set at 4223'. 50 bbls of cement was ran in the hole and circulation was lost. Continued to run cement in the hole and at 100 bbls circulation with return was received but did not come to surface. A temperature survey was conducted and concluded that the cement reached 660'. The Nacimiento formation is approximately 2250' so the cement is above the formation and remediation is not required at this time. Steve Mason (BLM) and Charlie Perrin (OCD) were contacted and verbal approval was received.
