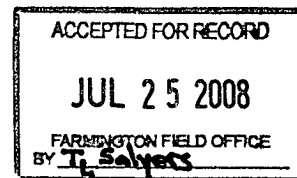

The above referenced well was spud on 7/19/08 at 8:00 pm. ✓

Drilled 12 1/4" hole to 310' on 7/19/08, set 7 jts of 9 5/8", H-40, ST&C, 32.3# casing at 300'. Cemented w/200 sx (42 bbls) "G" cement w/2% CaCl and 0.2#/sx Poly-E-Flake. Circulated 20 bbls of cement to surface. Casing would not test. Drilled out to 310' and on 7/21/08 dumped 70 sx (15 bbls) "G" w/2% CaCl. Tested casing to 800 psi.

Did casing hold the 800 psi? If so, how long was the test?
