Pumped 235 sx (282 cf - 50 bbls slurry) Type 5, w /Bentonite, CACL2, Cellophane Flakes. Dropped plug & displaced w/22 bbls FW. Bumped plug to 230#. Circ 26 bbls cmt to surface. ND BOP & NU WH. RD & RR 8/1/08.
